### **President's Message**

If you don't follow the philatelic auction scene, you are probably not aware of the recent sale of a very rare first issues related cover. It occurred last October in the sale of the William Gross collection by Robert Siegel Auction Galleries. Described as "one of the most desirable covers in all of classic worldwide philately", it realized \$300,000 USD. The cover, franked with a Province of Canada 3 pence Sc#1 and a US 5 cents Sc#1, was sent from Montreal to New York with a date stamp reading "Montreal L.C. JU 8, 1851". On April 6 of that year, a postal treaty between Canada and the USA greatly simplified correspondence between the two countries and established a postal rate of 6 pence for Canadian letters to the US and 10 cents for US letters to Canada - but for years before that treaty, it was possible to buy the 1847 US stamps in Canadian post offices to prepay the American portion of the postal route. The 1847 US stamps were no longer valid for postage after July 1<sup>st</sup> 1851, so that cover was sent during the brief time window after the introduction of the first Canadian stamps on April 23 and the withdrawal of the first US stamps. Although it technically skirted the rules of the new treaty, the mixed franking was nonetheless accepted by both post offices.

### The First Issue of Spain

In 1850, the Kingdom of Spain was one of the first countries to adopt the system of prepayment of postage, but it could have occurred much sooner. In August 1843, three years after the introduction of the first stamps by Great Britain, the Spanish Government instructed the Postmaster General to study the possibility of introducing postage stamps. This task, however, proved to be much more

difficult than anticipated. At the time, Spain already had a very developed postal system, but it was also complex and decentralized – so harmonization for the whole country contributed to delay the plans.

A rare 5c essay in orange (only two copies known to exist) is shown at right. The exact origin of the essay is unknown, but it has been speculated that it was produced in England - first because it resembles the first stamp of Mauritius and secondly because the denomination of 5 cuartos was equivalent to 1 British penny.

The designer and engraver of the first issue was Bartolome Coromina. Probably to save time it was decided to use the lithographic process for the production of the five different denominations selected, the 6 and 12 cuartos and 5, 6 and 10 reales. The artist chose a profile portrait of the young 19 year-old Queen Isabel II for the design and, just like Great Britain and Brazil had done before, the name of the country was omitted from the design. A left profile was used for the 6 cuartos and a right profile for the other four denominations.

In 1847, a British printing firm was asked how much they would charge for producing the stamps but, judging the amount to be too high, the Government decided to have the stamps produced locally. The new system was finally announced on Oct. 24, 1849 by Royal Decree. It was to begin on Jan. 1, 1850.

The 6c black was for single internal letters of  $\frac{1}{2}$  ounce or less, the 12c lilac for double weight letters, the 5r red for registered single letters, the 6r blue for registered letters to France and the 10r green for letters to Spanish colonies abroad. International letters other than for France were not prepaid except to Italy for which the Spanish rates applied. Sc#1, 3 and 4 were issued on Jan. 1; Sc#2 and 5 in early March.

For accounting purposes, it was decided to print the 6 and 12 cuartos stamps in sheets of 255 - which would amount to 180 and 360 reales per sheet, respectively, (1 real=8.5 cuartos). The 5 and 10 reales were printed 180/sheet (totalling 900 and 1800 r. per sheet), and the 6 reales at 150/sheet (900 r. per sheet).

Two plates were used for the 6 cuartos stamp. The stamps are easy to differentiate, in plate I the "T" and "O" of cuartos are distinct and in plate II they are joined. The two plating versions are shown below.

A total of 8,032,500 6c stamps were produced - so Sc#1 is very affordable compared to other classics of that period. The other denominations were produced in much smaller amounts. The key stamp in the set is the 10r worth \$1200.00 used. Used stamps are most often found with the black "araña" or spider cancel (designed not to deface the portrait when properly applied) but many other type of cancels can also be encountered.

Spain was certainly not the first country to introduce postage stamps, but it holds another distinction – that of having the first postal forgery (a forgery to deceive the postal service). A mere three months after the introduction of the stamps, postal workers in the town of Alicante spotted letters franked with fake 6c stamps. The stamps were traced back to the engraver Francisco Javier Martinez from Alicante and to the printer Vicente Pastor from Murcia. Asked at their trial to comment on the forgery, B. Coromina described them as being "vulgar and missing artistic intelligence". The one shown at right is the only known surviving copy and was offered at auction in Nov. 2018 with an opening price of 125,000 Euros!

You should also know that philatelic forgeries (forgeries to deceive collectors) of the first issue are numerous. Some are crude and not dangerous (10r shown below far left). Others can be very deceiving. A famous forgery by Miguel Segui from Barcelona done in the early 20<sup>th</sup> century is shown below (second from left). Dangerous forgeries by Sperati are also shown below (rightmost two). Many of these forgeries are very collectable and can be found offered by reputable auction firms bringing surprising realizations.

### **Possible New First Issue in the Future - Bougainville**

A small autonomous region of Papua New Guinea (PNG) known as Bougainville recently voted for independence from PNG. Bougainville was declared a province of PNG in 1976, shortly after PNG became independent from Australia in 1975.

The recent vote was in the form of a referendum question in which over 98% of voters expressed preference for independence over greater autonomy, The referendum was in accord with an agreement between PNG and Bougainville following a civil war that ended in 2001.

The vote is non-binding and PNG has the final determination of whether the area gets independence. According to Wikipedia, "Observers have said the clear result makes it difficult for Papua New Guinea to ignore or delay the result, but that independence could take years to achieve."

Although the Bougainville area will get most of its operating revenue by re-opening a copper mine closed during the civil war, I believe there is a substantial probability that the area will establish its own postal system and produce postage stamps when independence is achieved.

### Auction House Sales with Scarce #1s

Several auction houses held sales in November & December 2019 that offered scarce (and high priced) #1s and first-issue sets.

H.R. Harmer held their auction (Sale 3027) on November 13-14, 2019. Some intriguing lots were ...

- An Ethiopia Sc#N1-7 set in MNH condition
- Two German East Africa sets: Sc#N1-7 in mint/MNH condition and Sc#N8-14 in mint condition. I cannot recall ever seeing the German East Africa N1-7 and N8-14 sets for sale.

<u>Cherrystone Auctions</u> held a sale on December 4, 2019 entitled "The Hawkins Collection". As the title implied, this was a sale of one person's extremely nice collection of stamps from selected countries. Highlights included...

- The listings began with Albania, and immediately caught my attention. A series of 14 lots offered mint and MNH stamps ranging from Sc#1 through Sc#19. [I rarely see stamps from Albania that are not used.]
- For Austria, individual lots of all 5 stamps from the first issue in mint condition were offered.
- The Belgium section offered a scarce Sc#2 in MNG condition
- The Danzig section had a lot of that included 3 stamps from the first issue set that are noted in Scott (following the listing of #15) as "not regularly issued". These stamps are rarely seen at auction.
- A Luxembourg Sc#2 was listed as "unused with gum" defined as a mint-no-gum stamp with small specks of gum.
- The Portugal section contained Sc#1, 2, and 3b in MNG condition and Sc#5 as mint.
- Spain also offered a Sc#1a mint, #2 MNG, #3 mint, #4a mint and #5 MNG.
- The Swiss section, however, offered some very high CV items. Included were Zurich Sc#1L1 and 1L2 in MNG condition, two lots with Geneva Sc#2L1a (a left side single and a right side single, both in MNG condition), a Basel Sc#3L1 stamp in MNG condition. Further lots included Switzerland Sc#1 and #2 each in MNG condition, and a rare Sc#4 in used condition.

**Corinphila** had one of their semi-annual auctions in Zurich on December 3-7, 2019. [Note: Corinphila and H.R. Harmer are both in "The Global Philatelic Network" – an umbrella group that also includes John Bull Auction in Hong Kong and Heinrich Koehler Auction in Germany.] As with prior Corinphila auctions, this one did not let me down when I browsed the catalogues. I always wish I had a **LOT** more money to spend with them. I noted ...

- A couple of Tierra del Fuego lots each containing a used single. These were just the prelude, however. A "private treaty" sale of Brian Moorhouse's Tierra del Fuego collection was offered to anyone who had a mere 195,000 CHF (Swiss francs) in discretionary spending available. Unfortunately, my allowance does not extend to \$200,000 US dollars).
- Other lots outside my price range included two Great Britain Sc#O1 lots (one mint and one used an interesting offering for an unissued stamp).
- There was a full run of lots offering Mesopotamia Sc#N1-N5 (individually) and Transvaal Sc#1-6 (in groups).
- A Venezuela collection lot containing many stamps from the Carupano #1-5, Guayana #1-5, Maturin #1-5 and Marino #1-5 revolutionary issues was offered. [However, upon inspecting the detailed scans on the Corinphila web site, I believed the majority of these items were reprints.]
- More to my liking were two related lots: one contained a block of 6 stamps of Maturin #4 (original printing) and the other was a Guayana cover franked with Sc#5 (very rare considering the short 2-month usage period).
- Another lot that greatly intrigued me was a collection of Danube Steam Navigation Company (DDSG) stamps/covers selling in a single lot. I spent extensive time investigating the scans on the web site and ultimately determined a bid for the lot.

As is typical, my "desire list" from these auction catalogues **FAR** exceeded my budget. Of 33 desired lots in only the Corinphila auction, I bid on nine and won only three. I also won a couple of lots in the Cherrystone and Harmer auctions. Given that I rarely bid greater than 50%-60% of SCV (inclusive of auction fees), the low number of successful bids is expected. I consider all these purchases as early Christmas presents to myself.

- 7. Payment may be requested before shipment.
- 8. Bidding in this auction constitutes agreement to these rules.
